Thank you for your interest in Currumbin Wildlife Sanctuary's Green Challenge Thrill Seekers Program. This action packed, thrilling holiday activity has been designed for fun, fitness and team building, including the extreme ropes course, Surf World and Green Challenge.

With high Tarzan swings and a giant flying fox, the Green Challenge will test the agility and daring of anyone who takes on the course. It allows them to weave their way through the eucalypt and rainforest canopy, taking children higher and further into the spectacular natural setting. Children will work up an appetite and luckily food is all inclusive! Children will relax after their busy schedule with the opportunity to visit Surf world and meet some creepy crawlies before heading home

Please read the following very carefully. Currumbin Wildlife Sanctuary staff will do their very best to ensure the safety of your child. We aim to provide your child with a safe working environment. All staff possess relevant qualifications and first-aid officers are readily available on site.

It is essential we have this information as early as possible to avoid dissatisfaction.

Important information

Age; Green Challenge Thrill Seekers Program is open to children aged 10-16 years inclusive. **Children MUST be at least 160 centimetres from heel to both outstretched hands.** To avoid disappointment, please ensure your child is this height before booking into this program. Children under this height restriction will be unable to participate on the day.

Cost;

- \$59 per child.
- Additional siblings and friends at \$55 each.
- If you wish to have an animal photo it is an additional charge of \$13.00 and is either with a snake or koala

Times;

- **Start – 9am.** Children must be signed in so please arrive 5 – 10 minutes before 9.00am.
- **Finish – 3:30pm.** Children must be signed out so please arrive 5 – 10 minutes before 3:30pm.

Food provided on the day includes;

- Morning tea Served approximately 11:00am.
- Lunch Served approximately 1:30pm.
Consist of a Meat Pie and hot chips and a drink. (Special dietary requirements will be catered for on request)
- Afternoon tea Ice block.

Required by all participating children;

- Adequate protection for all weather conditions including a hooded raincoat for wet weather.
- We recommend children wear comfortable clothes as they will be in overalls while on the ropes course.
- Must wear comfortable enclosed footwear e.g. sneakers or running shoes.
- Must wear a hat and sunscreen at all times.
- Must be signed in by a parent or caregiver at the main entrance to Currumbin Wildlife Sanctuary.
- Must be signed out and picked up at the end of their session time 3:30pm (NO LATER) from the main entrance to Currumbin Wildlife Sanctuary. Supervision and safety can not be guaranteed after this time.

CURRUMBIN WILDLIFE SANCTUARY'S THRILL SEEKERS - LIABILITY RELEASE

In consideration of, and as a condition of my child's participation in Green Challenge Thrill Seekers.

I hereby:-

1. warrant that my child is medically fit (including physically and mentally) to participate in the Green Challenge Thrill Seekers Program;
2. agree that my child will participate in the Program at their own risk and I acknowledge that Green Challenge Thrill Seekers activities involve animal food, animal feeding, animal handling &/or physical contact, train rides and viewing of shows and exhibits and using the green challenge high ropes course that are potentially risky and dangerous and may result in personal injury and/or death to participants;
3. agree that my child will abide by the rules and conditions of the Program including those in any literature or verbal or written instructions;
4. waive, release and discharge all and any claim, right or cause of action howsoever arising, whether or not presently ascertained, immediate, future or contingent, which I may otherwise have for or arising out of loss of my child's life or injury, damage or loss of any description whatsoever and howsoever caused which my child may suffer or sustain in the course of or consequent upon their participation in the Program;
5. indemnify against any claim, right or cause of action howsoever arising whether or not presently ascertained, immediately, future or contingent which I or anyone else may have for or arising out of loss of my child's life or injury, damage or loss of any description whatsoever and howsoever caused which they may suffer or sustain in the course of or consequent upon my participation in the Program;
6. agree that the waiver, release and discharge contained in paragraph 4 above and the indemnity contained in paragraph 5 above shall operate in favour of The National Trust of Queensland and it's employees, assigns, sponsors, agents, officers, directors and related bodies corporate (as that term is defined in the Corporations Act), each the "released persons", and shall so operate whether or not the loss, injury or damage is due or attribute to an act, neglect or omission of any one or more of the released person;
7. agree that the waiver, release and discharge contained in paragraph 4 above and the indemnity contained in paragraph 5 above may be pleaded as a complete bar to any claim, notice, demand, action, proceeding, litigation or judgment which has or may be brought or made or recovered against any or each of the released persons.
8. I understand that my child;
 - Will be supervised by Currumbin Wildlife Sanctuary staff during session times.
 - Will interact with Currumbin Wildlife Sanctuary staff.
 - Will interact with live animals including physical contact.
 - Will undertake activities involving animal food & feeding, train rides & the viewing of shows & exhibits & green challenge high ropes course.
 - Will be provided with a snack and lunch.

Conditions of Entry – Adventure Parc Green Challenge

General Rules

1. The Green Challenge Adventure Parc opens 10am Monday to Saturday and 10am Sundays, Public Holidays and QLD/NSW School holiday periods. Last entry for the Green part of the Course entire course is 3pm.
2. The Green Challenge Adventure Parc is designed to add progressive challenges as you move through the courses. It is not designed as a hop on hop off activity. Should you wish to break from the course at any point you are welcome to do so. However, as overalls and harnesses need to be kept in good order, you must hand these back before venturing into the general Sanctuary area and your activity is deemed to cease for the day.
3. Entry requirement: You must be 6 years old or **above and at least 160 centimetres from heel to both outstretched hands, 180 centimetres on the Black Course.**
4. The Green Challenge Adventure Parc activity implies some risks and is suitable only for persons physically and mentally able to sustain a minimum of physical and exertion and stress.
5. The activity is not recommended to pregnant women, people with heart problems, high blood pressure, back problem or any other adverse medical condition.
6. The equipment provided (overall, gloves, harness, safety straps and pulley) is checked daily by our staff and must be used according to the instructions given.
7. Closed shoes must be worn to do this activity.
8. Long hair must be tightly tied away from face.

Safety

You must attend the Video Presentation on the safety rules.

1. Your safety straps (red karabiners) must always be fastened according to instructions and you are required to wear gloves when directed on the Green Challenge Adventure Parc.
2. For your enjoyment, choose games' level suitable to your ability, our staff are there to help you. There are 3 parts of the course:
 - a. **Green Courses:**
 - Beginner Level.** This must be attempted first.
 - b. **Red Courses: (not avail after 3pm)**
 - Intermediate Level.** This part requires more physical effort. Please estimate your ability before attempting this.
 - c. **Black Course: (not avail after 3pm)**
 - Challenging Level.** This course is the hardest. Do not overestimate your capabilities.
3. If you are unsure, consult our staff.
4. DO NOT overload the games. 2 persons per game at a time, 1 person on a Pulley game and 3 persons on a platform at a time only.
5. To ensure safety and everyone's enjoyment, the capacity of the whole Green Challenge Adventure Parc is limited to 130 people maximum and one time.
6. Once the limit is reached, entry may be restricted for individuals or groups at any time.
7. Management reserves the right to expel any person who does not abide by the safety rules and who, by doing so, puts his/her life or the lives of others in danger.
8. Management reserves the right to close the park in case of bad weather.

Smoking, consumption of alcohol and use of drugs are NOT ALLOWED in any part of the Green Challenge Adventure Parc!
